## Planning

24/00759/PLF – Erection of a single storey and two storey extensions to side following demolition of existing and construction of extension to existing dropped kerb – 17 Station Road, Nafferton – application withdrawn

24/01526/TPO – Nafferton Hall, Nafferton – 1984 (ref 413) T3 Nafferton Conservation Area – Remove 1 Norway Maple tree as it has been in decline for the last two years and concerns that its proximity to would result in substantial damage were the tree to fail – 9 Parsonage close, Nafferton

24/01538/TCA – Nafferton Conservation Area – Crown lift 1 Himalayan Birch Tree (T1) by 5 metres and crown thin by 10% to reduce excessive loading on lower canopy unions and encourage development of a more upright framework as it is overhanging adjacent gardens, has a low canopy, and is leaving debris and dead wood on vehicles – Chestnuts, 5 Parsonage Close, Nafferton

24/1610/TCA – Nafferton Conservation Area – Fell 2 Leylandii Trees (T1 and T2) and crown reduce 1 Beech Tree (T3) by 2 metres to create a balanced shape – Cherry Tree Cottage, 31 Westgate, Nafferton
