E93 Open Forum

Vermin at The Mere, the Allotments and at the Recreation Club exterior site. – Councillor P. Sharpe proposed contacting Mr. John Buckton to review and provide information – seconded Councillor N. Waites – all in favour of Mr. Buckton liaising with Mr. R. Holmes

A member of the public reported that rats had been seen at The Mere eating the food put down for the wild birds.

It was noted that the Nafferton web site is hardly populated – Councillor N. Waites told the meeting that to have an efficient web site took a lot of time to keep up to date.

The disrepair of footpaths in the village was discussed – these were noted on the Village Streetscene Walkabout in June 2023.

The Councillors were requested to speak louder and not talk over each other.

Planning application: 23/03040/PLF – Change of use of land to allow for the siting of six glamping lodges and associated infrastructure (re-submission of 20/03312/PLF) (retrospective application) – Kesters Farm, Wold Road, Nafferton – the application had been viewed and discussed – Councillor N. Sawyer proposed that the Parish Council object to the planning application on the grounds of the original planning consent had not been adhered to: the passing place on a single track road is in the wrong place on a bend between thick mature hedges – object on the grounds of highway safety – seconded Councillor P. Sharpe

E77 Filming of meetings The filming of meetings was discussed Councillor C. Milan told the meeting she was not in favour of meetings being filmed but if it was agreed to film meetings then it should be filmed by an agreed Council Member – Councillor P. Milan proposed that if it was agreed to film meetings the Councillor N. Waites should be the delegated Council Member – not to be placed on any social media portal without the Councils permission – seconded Councillor Webster. Councillor Waites to obtain prices for a recording system – November agenda – see E95

Tait suggested that perhaps an audio system for recording meetings would be acceptable and less expensive – Councillor N. Waites agreed Councillor S. Tait proposed that the recorded meetings if not live streamed should be on the web site as soon as possible after the meeting – seconded Councillor N. Waites – 7 for the proposal – 1 against – 2 abstentions

The maintenance of the island was discussed – Councillor Sawyer to contact Tree arborist for a report on the trees on the island and the tree on Priestgate – on going

The last Ecology Report on The Mere was carried out in 2012 – Councillor Tait to obtain quote for new report – on going – Councillor Tait reported that she had received and initial quote of £2800 for an Ecology Report – request 2 further quotes – Councillor Tait awaiting a quote from Yorkshire Wildlife and another.

Councillors Sharpe, Tait and P. Milan reported on the meeting they had attended with a representative ERYC. Councillor N. Waites suggested that it should be agreed to consider a new ecology report as a long term sustainable plan – on going Councillor S. Sharpe reported on the maintenance of the Mere and clearing of the horsewash – on going

E85 Councillor Waites suggested a Wild life trail camera to record the wild life at The Mere – Councillor N. Waites to discuss the Mere Reps – a budget of £100 was agreed – seconded Councillor Sheldon - E85 Councillor Waites suggested a Wild Life trail camera to record wild life at The Mere – Councillor N. Waites to discuss with Mere Reps – a budget of £100 was agreed – seconded Councillor Sheldon – Councillor C.
