Councillor P. Milan in the process of completing forms to submit to ERYC for permission to carry out the required work on the trees on The Mere Island and on Priestgate with advice from an arborist

The last Ecology Report on The Mere was carried out in 2012 – Councillor Tait to obtain quote for new report – on going – Councillor Tait reported that she had received an initial quote of £2800 for an Ecology Report – request 2 further quotes – Councillor Tait awaiting a quote from Yorkshire Wildlife and another.

23/03559/PLF -Erection of single storey extension to rear following demolition of existing conservatory and conversion of existing integral garage to create additional living accommodation and construction of bay window to front – 25 St Quintin Field, Nafferton – we have no observations to make on this application

23/03573/PLF – Installation of second floor glazed doors with Juliet balcony to side elevation – 42 West End Falls, Nafferton – we have no observations to make on this application

23/03817/TCA – Nafferton Conservation Area – Crown reduce 1 Horse Chestnut Tree by 4 metres due to excessive shading in the garden and reduce 1 Ash Tree to previous height at 6 metres due to overgrowth – Springfield House, 8 Station Road, Nafferton – we have no observations to make on this application

Councillor Sheldon to contact Mr. Lundy with reference to the small piece of land on Priestgate and the small triangle of land near to the horse wash to ask if the registration of these pieces of land had been completed in favour of the Parish Council– on going

E118 Nunnings/Priory Close – hedge – on going – quote received for the plants - £4.45 each – Councillor N. Sawyer proposed a budget of £300 for purchase of the plants and £40 for the signs – seconded Councillor Sharpe – all in favour

Parish Council to inform residents with a letter drop and inform of the next PC meeting

Councillor Tait had received quotes for the full refurbishment of both telephone kiosk in the village the cheapest being £3000 per kiosk plus carriage – Councillor Tait proposed that the cheapest quote was not acceptable to refurbish the telephone kiosks – seconded Councillor Sawyer – all in favour

Councillor Milan told the meeting that a village group had volunteered to refurbish the kiosks and proposed that any expenses would be covered by village maintenance – the work to be carried out in the spring – seconded Councillor Sharpe – all in favour

Station Road kiosk – after discussion and the advice taken on moving telephone kiosks Councillor Sawyer proposed that the Station Road kiosk should remain in situ on Station Road – seconded Councillor Wild – all in favour

Potholes – Nafferton to Driffield – Councillor Dewhirst advised that they should be reported to ERYC on the website.
