*The last Ecology Report on The Mere was carried out in 2012 – Councillor Tait to obtain quote for new report – on going – Councillor Tait reported that she had received an initial quote of £2800 for an Ecology Report – request 2 further quotes – Councillor Tait awaiting a quote from Yorkshire Wildlife and another.*

It was noted that corn fed to the wildlife in The Mere was germinating and polluting the water

#### E142 Flooding/Drainage Report

*Nethergate and Nafferton Slack – Councillor Dewhirst /Owen– the remedial work had not cleared the problem – on going*
