- e. **STAFFING** It was noted that the previous Clerk is working ad-hoc hours to facilitate bank payments and support the new Clerk.
- f. **UPDATES FROM OTHER COMMUNITY GROUPS -** Nafferton in Bloom kindly agreed to tidy the troughs at the War Memorial.
- **10. Parish Council Facilities** To receive a report and approve/record any action needed for the following:

#### a. NAFFERTON MERE

i. Councillor Tait updated regarding the Mere Management action plan and advised that work on habitat management could not begin until excessive feeding of the ducks has ceased.

The Freshwater Trust documentation has been reviewed as requested by a member of the public and it was found to have stated that 'one of the top pollutants is a high number of ducks.'

James Spencer gave an insight into the current situation and agreed to provide on-going support to the Parish Council surrounding the habitat management plan.

Following an FOI request to Yorkshire Water it has been found that there have been no complaints regarding sewerage discharge into the mere for the last 2 years.

- ii. The purchase of a replacement life buoy was agreed.
- iii. The sluice area and entrance to Nafferton Beck was discussed, Councillors Sheldon and Wild to visit and assess for inclusion on the next agenda.

#### b. **PLAYGROUND**

- i. Following assessment by Councillors Sheldon and Sawyer it was agreed that three quotes would be sourced to replace the playground fence as repair was not feasible.
- ii. The zipline seat tubing has been damaged. Councillor Wild agreed to investigate repair.
- iii. It was noted that Ross Holmes would fix the playground gate with the assistance of Councillor Sharpe.

#### c. ALLOTMENTS

- It was agreed that Ross Holmes would replace posts as necessary.
   Tenants are reminded that no sheds are allowed to be placed on plots.
