The member of public present requested clarification of an item in the latest newsletter – "Nafferton Mere is owned by Nafferton Parish Council and under no circumstances must anything go in or on the Mere without prior approval at a Parish Council Meeting" Councillor Sheldon proposed that permission must be applied for by any individual (in person or in writing) to the Parish Council to go in the Mere or put anything in The Mere – seconded Councillor Sharp
