E63 Ms Tagg disputed the accuracy of the minutes of the last meeting, after discussion and a vote (5 for -1 against – 3 abstentions) having been circulated were agreed and signed – proposed Councillor C. Milan – seconded Councillor Buckton – all in favour Ms Tagg wished it to be recorded that in her opinion there is no evidence of vermin at the water

Speeding in Nafferton – refusal to reduce the speed limit to 20 mph

E65 The Mere

Councillor P. Milan to obtain quotes to erect a metal fence to the entrance of The Mere after concerns for the health and safety of the public – Councillor P. Milan had received an initial quote of £2400 plus VAT

The maintenance of the trees on the island were discussed – Councillor Sawyer receiving advice from an arborist

Councillor P. Sharpe reported that the Willow Tree on the island appeared to have a broken branch – *on going*

Councillor Sharp had carried out some maintenance work on the small piece of land adjacent to 5 Priestgate

The maintenance of the island was discussed – Councillor Sawyer to contact Tree arborist for a report on the trees on the island and the tree on Priestgate – on going

The last Ecology Report on The Mere was carried out in 2012 – Councillor Tait to obtain quote for new report – on going – Councillor Tait reported that she had received and initial quote of £2800 for an Ecology Report – request 2 further quotes – Councillor Tait sent an update awaiting a quote from Yorkshire Wildlife and another

Ms Tagg had written to Yorkshire Water reference an Ecology report Clearing of the horsewash – date to be agreed

Councillor Waites raised the matter on the best way forward to manage the Mere and felt that an Ecology report would be helpful to the Parish Council – Councillor Sheldon agreed – Councillor Waites to check progress with Councillor Tait.

Councillor Owen to forward details from the ponds and waterways team at East Riding.

Nethergate and Nafferton Slack – Councillor Dewhirst /Owen– the remedial work had not cleared the problem

Councillor Wildridge reported that the drains on Westgate had not been cleared of sand by ERYC – Clerk to contact
