Councillor Sharpe asked Councillor Tagg if she would be able to litter pick the Play area from 25.9.24 to 10.10.24 in his absence – Councillor Tagg agreed

Councillor C. Milan – proposed the erection of a Community noticeboard in the area of the Bus Shelter on Driffield Road – subject to planning permission – Councillor Milan presented to the meeting designs and colours of noticeboards – Councillor Sharpe proposed from the designs a silver frame with blue interior – seconded Councillor H. Waites – Councillors voting in favour of the proposal C. Milan/P. Milan/S. Tait – Councillor Tagg voted against the proposal

The meeting discussed the possibility of installing seats in the bus shelter – quotes required – Councillor C. Milan circulated different designs but non seemed to be appropriate for the Bus Shelter – Councillor C. Milan proposed that a local fabricator be asked to supply a quote – seconded Councillor P. Milan – Councillors voting in favour of the proposal P. Sharpe/S. Tait/Y. Tagg/H/ Waites

Telephone kiosks – Councillor P. Sharpe proposed that the telephone kiosks should be known as Nafferton Community Libraries – seconded Councillor P. Milan – Councillors voting in favour of the proposal C. Milan/S. Tait/Y. Tagg/H. Waites – Councillor C. Milan to arrange frosted plastic with the inscription.

Humberside Crime Commissioner CCTV grant - on going

Councillor P. Milan attempted to raise concerns regarding a pile of stones in the horsewash but was interrupted by Councillor Tagg who began shouting over him. Councillor Tagg was reminded by the Chairman that this was not acceptable behaviour

in a Council meeting and asked Councillor Tagg to behave in a more appropriate manner. Councillor Tagg did not moderate her behaviour and continued to disrupt the meeting. As this was the final item on the agenda the Chairman brought the meeting to a close.
