Y141 Open Forum

- A member of the public asked for advice regarding the erection of fences in what he believed was an open plan area – Councillor Sharp to contact ERYC housing department for an update and report back to the resident – update PC at March meeting
- Councillor Buckton left the meeting
- Dr. Wigglesworth – Traffic and grass verge damage on Nethergate –
- Dr. Wigglesworth outlined the problems on Nethergate – he had written to ERYC highways and they had responded – (copy on file) – Clerk to request from ERYC programme of works for repairing the damaged areas on Nethergate and the enquire about the placing of boulders on the edge of the verges.
- Councillor Buckton returned to the meeting
- 2 members of the public were concerned about events being held at the Recreation Club – the PC appreciated their attendance and their concerns
- Damage to highways/verges – Councillor Tait had information from Stubbs Bros that work to repair the damage would commence during week beginning 26 February 2018
- Speeding in the village was discussed – it was pointed out that there are no give way signs between Eastlands and Eastgate – Councillor Tait proposed that the PC contact highways for advice – seconded Councillor Darbinson – all in favour
- Lights at the Recreation Club – Councillor Tait to meet with Stubbs Bros – update March Recreation Club Meeting
- One way system at The Recreation Club – temporary sign to be erecting indicating the one way system
- Bus Shelter – The condition and maintenance of the Bus Shelter was discussed – Councillor Sharp told the meeting that if necessary ERYC would remove the graffiti – but it was agreed that painting would solve the problem
