## Y3 Open Forum

The member of the public – Dr. M. Jackson requested an update on the proposed allotments – awaiting quotes for the provision of the access to the site.

#### Y4 New Build

Mr. T. Stephenson from Stubbs Bros. updated the meeting on the progress of The New Build. The new road and car parking area should be completed by the end of May. The upgrading of the electricity supply should also be completed by the end of May.

Handrail – The lack of a handrail at the steps access to the Recreation Ground was discussed – Mr. Stephenson had produced a photograph showing that there was no handrail at the site in September 2016 before the construction work began. Councillor Tait ask Mr. Stephenson to prepare a quote for a new handrail. Councillor Nicholson proposed that the Parish Council should clarify the ownership of the land. Stubbs Bros cheque for £108,665.26 handed to Mr. Stephenson along with the VAT Zero Rated note reference VAT note 708.

New Building Name – Councillor Tait proposed that the new building at the Recreation Club should be named Nafferton Recreation Club – seconded Councillor Carr – all in favour

Councillor Tait proposed that a plaque should be placed on an exterior wall of Nafferton Recreation Club building acknowledging the Feoffee Charity funding of the building – seconded Councillor Nicholson

Mr. Stephenson left the meeting.

Councillor Webster enquired if the kerb would be dropped at the access area to the proposed allotments road whilst kerbing was in construction for the new Recreation Club Road – Councillor Tait to contact Stubbs Bros.
